October 22: Write-in period for alternative nominations ends

October 23 - November 22: Online voting open

November 22: Virtual members meeting to finalize and announce election results

ORCID IN THE AMERICAS

Registry traffic: Individual Researchers

+21% in Latin America (1.2M → 1.5M),

+12% in US & Canada (2.4M -->2.75M)

Four consortia:

Brazil, Canada, USA (2)

Membership: Organizations

+38% in Latin America (21 -->34),

+36% in US & Canada (259 -->275)

Integrations: Organizations connecting systems

+31% in Latin America (9 -->16),

+29% in US & Canada (177 -->249)
